The war on women continues.

In another attempt to destroy our culture, the Biden Administration subverts the very reason that Title IX was created. Rather than protect girls and female athletes by providing a safe and fair playing field, subpar male athletes may now bully their way into every aspect of school athletics.

Parents, educators, and lawmakers across the country are rightly concerned about the damage these changes will have on both the mental and physical well-being of female student athletes.

Talking points:

- Schools will have to construct new accommodations for transgender students and protect the privacy, safety, and fairness of existing female student athletes.
- Neglects science allowing biological males to participate in female athletics puts biological females at a higher risk for physical injury.
- Limits female's ability to seek awards and scholarships.
- All students deserve privacy and safety in sex-separated spaces (such as locker rooms, restrooms, and athletic-medical rooms).
- Female athletes deserve to compete in fair, honest, and safe athletic competitions free from the threat of major medical injury or unfair competition against biological male athletes.
- Female athletes will no longer have equal rights to female-only sports teams instead of protecting women, the rule requires schools to "minimize harms" to males identifying as women.
- In elementary and middle school, girl's teams are essentially banned.
- In high school and college, female athletes must prove they are harmed before any trans-identifying male is kept out of their sport and locker room.
- For any sport, at every age and level of competition, schools must prove an "important educational objective" before restricting any transidentifying male from a female team.

Biden's proposed rule flips the burden of proof against female athletes. It gives males who declare "womanhood" the upper hand in challenging any policy seeking to keep sports teams based on biology, not identity.

This was NEVER the intent of Congress under Title IX.
